Subject:- Essentiality of studies for annual rate of replenishment in case of river sand mining .

It is for the information of all concerned lease holders of River Sand Mining. Vide Notification dated 15-01-2016 and 25-07-2018 of GoI, MoEF&CC, the main principle of river sand mining is based on sustainability. It has to be calculated / studied for preparation of Annual Rate of Replenishment and allowing time for replenishment after mining in the area if required. Mining has to be prohibited / controlled if there is no replenishment or insufficient replenishment. Accordingly in Environmental Clearances issued from this Authority a condition is stipulated to furnish Annual Replenishment Rate by the Environmental Clearance holders (Project Proponents). Even if condition of Replenishment Studies are not mentioned in any Environmental Clearance issued from this Authority; the Project Proponents are advised to consider the same included in the Environmental Clearances additionally.

In the light of above facts all the Environmental Clearance holders of River Sand Mining are directed to furnish report of Replenishment Survey clearly indicating the Annual Rate of Replenishment (pre-monsoon & post-monsoon) vis-à-vis annual extraction of sand allowed and amount actually removed in last one year (Pre-monsoon & Post monsoon both). In case where the above said report is not made available by the end of September: 2018 their Environmental Clearance may be withdrawn or kept in abeyance till the required report is furnished. It is for the information of all concerned that in its direction dated 28-02-2018 in the matter of Civil Appeal No. 11808/2016 Hon'ble Supreme Court has sought information regarding Replenishment Studies from the GoI, MoEF&CC. In its turn GoI, MoEF&CC has directed to show cause the defaulters if any.


